## Give Me 10 Update

Correspondence on August 31<sup>st</sup> from the Military Officers Association of America (MOAA) gave a report on the status of our organization's recruiting efforts, paraphrased here:

Summer is ending and many chapters are now resuming "full operations" after a reduced summer schedule. Our end of August **Give Me 10!** (GMT) report show that our national chapters have recruited 3,624 new members. This is down from the number recruited at this time last year.



We at MOAA expected some reduction when we placed greater emphasis and incentives towards paid members at the start of this year. Now that chapters will soon be back in their fall meeting schedules, we hope to regain momentum in

our recruiting efforts for the last four months of the year. We can still reach our end-of-year goals with your continued support.


We have one month left in our 3<sup>rd</sup> Quarter competition between councils and independent chapters in the four regions, and some of the races are close. To review the 2010 rules – Independent chapters must recruit a minimum of 4 new paid members in order to win a quarterly competition. Chapter members who convert to life memberships count towards the monthly and quarterly paid member totals. The quarterly independent chapter winners will receive a check for \$250. Independent chapters cannot win in consecutive quarters.

September is the month to "surge" and turn in the GMT membership applications to insure timely processing. The 3<sup>rd</sup> quarter winners will be identified in early October.

Each fall we remind those of you who support university and high school ROTC/JROTC programs to "re-connect" with the cadre/instructors. Well, it is that time of the year again. Remember to recruit the newly

assigned cadre/instructors under the GMT program and look ahead to next spring for the commissioning of cadets/midshipmen. The senior ROTC programs offer a great opportunity for recruiting under the Gold Bar program, which will be back in 2011. Get involved and support your local programs.

### Health Care Reform to be Paid for by Cuts to Medicare

The enormous, socialized health care bill signed into law earlier this year will be largely paid for by cuts to services many seniors depend on. You may be unaware, but here is just a sampling of the Medicare cuts, totaling more than \$500 billion, to come:  
In 2010:

- Medicare will cut reimbursements to inpatient psychiatric hospitals.

In 2011:

- Medicare cuts to home health agencies begin.
- Medicare cuts begin to ambulance services,

## Travel and Leisure

We've had meetings and newsletter articles about Space-A travel, but what about a place to stay or visit when you get to where you're going? What if you're driving and are in the area of a military base that may offer reasonable, comfortable accommodations instead of an expensive hotel? Did you know that there are more than 400 military bases, posts, and stations that offer lodging? In addition to the official lodging facilities at which you may stay at these installations, they may also offer recreational lodging, *e.g.*, Bellows AFS. Lodging information may be found at <http://dodlodging.net/> for Navy and Air Force lodging, [www.usmc-mccs.org](http://www.usmc-mccs.org) for Marine Corps lodging and [www.armymwr.com](http://www.armymwr.com) for Army lodging.

The military also operates five Armed Forces Recreation Centers overseas and in the U.S. The Dragon Hill Lodge in Seoul, Korea; the Edelweiss Lodge in Garmisch, Germany; and, stateside, the Hale Koa in Honolulu, Orlando Disney World (the Shades of Green), and the Ft. Story, VA (the Cape Henry Inn and Beach Club). Room rates vary and are on a sliding scale favoring junior personnel in rank/rate. The Navy runs a similar resort in Tokyo, as you may know, called the New Sanno Hotel with rates considerably lower than normal Tokyo hotel charges. More information may be found at [www.thenewsanno.com](http://www.thenewsanno.com). Not to be left out, the Air Force is allied with the Rocky Mountain Blue at Keystone Resort. Located about an hour and a half from Denver's Stapleton Airport and two and a half hours from Colorado Springs, it is located in prime ski and snowboarding country. Go to [www.rockymountainblue.com](http://www.rockymountainblue.com) for more.


The Armed Forces Vacation Club (not directly connected to DoD, but in association with the various service MWR operations) can provide a search capability for space-available vacation rentals for relatively low prices. They are more or less a consolidator and sell unused time-share and other discount travel and cruise packages. You may find more information at [www.afvclub.com](http://www.afvclub.com).

Another resource for discounted travel and vaca-

tions is Government Vacations Rewards (GVR). Operated through and connected with the various military exchange systems, GVR is a travel discount program specifically designated for government employees and military personnel (active duty, reservists, veterans and retirees) to save money on their vacations. You will have access to the savings on-line at [www.govvacationrewards.com](http://www.govvacationrewards.com) or by calling their vacation consultants. Government Vacation Rewards offers over 40 cruise lines and more than 4,000 different resort properties at major destinations worldwide with no blackout dates. Every booking comes with a Best Price Guarantee, and even friends and family members can take advantage of the prices. A portion of GVR proceeds support the DoD MWR activities, the Wounded Warrior Program, and Vacations for Veterans.

To access their discounted prices and take advantage of their savings, Government Vacation Rewards requires that you have a membership (free) in the program. Since their prices and discounts are not available to the general public, they only make the site available to eligible participants. Comparing prices at several travel sites and airlines with GVR's prices, they were essentially the same (without booking fees) and the latter has the advantage of supporting the military.

Both AMTRAK and Greyhound offer discounts as well as many cruise lines. Military discounts on airlines are for full fares only and are almost always more than other discounts. Most of the theme parks offer a military discount.

Remember, whenever you are making a purchase, a reservation, or travel arrangements, always ask if they give a military and/or senior discount (if eligible). It generally won't be offered. It doesn't hurt to ask (saving the seller of the embarrassment of having to ask if you are old enough for a discount, for example) and you deserve it. Bon Voyage! **ausn.org**

ambulatory surgery centers, diagnostic labs, and durable medical equipment

- Seniors are prohibited from purchasing power wheelchairs unless they first rent for 13 months.
- New Medicare cuts to long term care hospitals begin.
- New Medicare cuts to hospitals and cuts to nursing homes begin (FY12)
- Medicare Advantage cuts begin. Participating seniors will face premium increases, benefit cuts, or both.

In 2012:

- Medicare reimbursements for dialysis treatments are cut.
- Medicare cuts to hospice begin.

In 2013:

- Medicare reimbursements to hospitals that serve low-income seniors will be cut.

**WHAT THIS MEANS FOR YOU:** When providers get paid less by Medicare for services sen-

iors depend on, many may be forced to decrease their services or close some of their locations just to make ends meet. This means that seniors may experience a decrease in their access to essential care, which is already a problem for many in rural districts. Many doctors are already limiting their services by accepting no more Medicare patients.

The cuts to Medicare Advantage may cause many of these insurance providers to stop offering plans to seniors, forcing seniors back into traditional Medicare.

**THE DIAGNOSIS:** Seniors should not have to bear the cost of health care reform. Instead, we need common-sense health reform that will lead to quality, affordable health care, without breaking the bank, or cutting services to seniors. We need tort reform, inter-state competition, portability from one employer to another, and more competition, not a sole provider. First of all, we need to repeal this terrible healthcare bill!
