MG James M. Dubik is no stranger to Hawaii, having previously served as the 25th ID's Inspector General and Commander of the 5th Battalion, 14th Infantry. Assuming Command of the 25th Infantry Division( L) and United States Army , Hawaii in the fall of 2000, the Army could not have selected a better qualified Commander to meet today's current challenges in Hawaii.

General Dubik received his commission as a Distinguished Military Graduate from Gannon University in 1971. A truly Renaissance Man, he has served in the trenches with his fellow Infantrymen—in Ranger and Airborne units, has run a gamut of the tough deployments from Northern Haiti to Bosnia—Herzegovia.

### TROA Urges Healthcare Funding

General Joe Hoar, USMC (Ret), Chairman of TROA's Board of Directors, wrote the Secretary of Defense March 22, requesting urgent action to address the \$1.4 billion healthcare shortfall. "This shortfall already is imposing negative effects on active duty and retired families," said Gen. Hoar, "and the...situation will worsen...if additional funding is not forthcoming soon. Our top concern remains timely and fully funded implementation of TRICARE For Life (TFL) on October 1," stated Gen Hoar in his letter. "We know the Department will... make this happen, but worry about the long-term readiness and quality-of-life impacts of absorbing these costs without additive funding. I urge your special attention, as a matter of priority, to redressing the FY2001 Defense Health Program shortfall."

Editor note: The March issue of the TROA magazine contained a postcard to sign, stamp, and mail to your Washington legislators. These post cards are a simple means of letting your representatives know how you stand on the issue; however, a more effective way is to rewrite the postcard, by as little as changing "happy to glad", and mailing it as a letter.

### TROA Presents VA Testimony

On March 22, Deputy Director of Government Relations COL Bob Norton, USA (Ret), presented TROA's legislative agenda on veterans issues before a joint panel of the Senate and House Veterans Affairs Committees. Norton applauded the House Committee's March 21 approval of a 12% VA budget increase, aimed at reducing the huge backlog of veterans benefits claims.

He also endorsed H.R. 801, which would: make the new \$50,000 increase in Servicemen's Group Life Insurance coverage retroactive to October 1, 2000, to cover survivors of the USS Cole and other recent accidents; authorize SGLI coverage for active duty family members; increase GI Bill benefits; and expand VA outreach services to eligible dependents of deceased veterans. (The House Committee approved H.R. 801 on March 21.)

But Norton expressed TROA's strong opposition to

an administration proposal that would force disabled military retirees to choose either VA health care or the military health care system (TRICARE) as the source of their health care. Retirees earned their military coverage through their decades of service to the country, he noted, and disabled retirees also need the VA's unique services for the disabled community.

### Flag-Protection Amendment Introduced

Identical bills have been introduced in the House and the Senate that would create a constitutional amendment prohibiting the physical desecration of the flag of the United States. During the last Congress a flag-protection amendment passed overwhelmingly in the House by a vote of 305-124. In the Senate, however, the amendment fell four votes short (63-37) of the two-thirds majority required for passage of a constitutional amendment. American Legion commander Ray G. Smith said. "Here we have an amendment supported by 49 state legislatures and 80 percent of the American people. I urge Congress to heed its own advice and pass this amendment now," he said.

### Pharmacy Benefits Began April 1st

TRICARE Senior Pharmacy benefits are now available to retirees 65 and older. Be sure to read the literature that DOD sent to all eligible beneficiaries. If you have not received correspondence, you should check with DEERS or the office that issued your military or dependent ID card or call 1-877-363-6337.

### Chimps Get It Too

Military retirees were not the only ones that got lifetime health care enacted by the 106th Congress. PL 106-551 establishes a national sanctuary system that provides permanent retirement and health care for federally owned or supported surplus chimpanzees that are no longer needed for research or breeding purposes by the US government.

**Why the Army is not required to do an Environmental Impact Statement**

There have been a stream of articles and letters to the editor in our local newspapers criticizing the Army for not performing the process that would culminate in what is known as an Environmental Impact Statement. In most cases the opponents of resuming live firing in Makua Valley are using this as a delaying tactic. They know the EIS entails a very expensive, resource consuming process taking three years to complete the studies and reviews. The combat readiness of the 25th Infantry is all too important, not only at the Brigade or Company level but also for the safety of the individual soldier, to further delay resumption of live firing. Fundamental to this is that an EIS is not required by law.

In complying with the National Environmental Protection Act the Army conducted the required Environmental Assessment. In doing so, one of the first steps taken was to meet with the U. S. Fish and Wildlife Service and the State Historic Preservation Office. The Army presented its plan for resuming live firing at a reduced level from previous training and in a more confined area. Fires are a concern to all so the Army will no longer use illumination rounds, tracer ammunition, aerial rockets nor anti-tank missiles, and will limit training to the Company level. Both government agencies responded in writing stating, respectively, “no jeopardy” to endan-

gered species and “no adverse effects” for cultural properties.

The EA did reveal a number of issues, several of which were concerns expressed by the community, e.g., possible underground water contamination, transporting ammunition on Farrington Hwy, etc. These issues have been addressed by a Supplemental Environmental Assessment and the results presented to the community over the last few weeks.

Neither the EA nor its Supplement has revealed the need to do an Environmental Impact Statement using the guidance of the NEPA. Critics continue, however, with much rhetoric while the Army rigorously adheres to the NEPA’s process. Furthermore, there is a precedent that could be set if an EIS were required for Makua Valley which is exactly the goal of some critics. Conceivably, the Army could be required to do an EIS at every installation on the main land where live firing is conducted.

It is no secret that there is a segment of the community that would like to see the military totally removed from the state of Hawaii. The actions taken by this small minority in the case of Makua Valley are being supported by Earthjustice, which formerly was the legal arm of the Sierra Club but is now independent. Litigation by Earthjustice to require the Army to conduct an EIS has been placed on hold by the court pending the Army’s submission of the Supplemental EA. We trust that the wisdom of the judge will result in a favorable decision to the Army.

### Hawaii Chapter recognizes Lucille and Nelson Shreve

Once upon a time, as the saying goes, two very special people joined Hawaii Chapter — and from that day forth Lucille and Nelson Shreve have played a significant role in the life of our chapter. As long as I can remember, Nelson had the enviable task of publishing our Pau Hana Koa. It took a case of pneumonia in January 2000 for him to relinquish this duty. What many do



not know, is this dynamic duo wrote and directed Lanikai Mortgage Players Productions. On the 18th of last November, the Mokulua Fishing Club presented a plaque to both for their 25 years of effort to their community, which read “ The Hero and Heroine of Lanikai”, which is now permanently mounted in their Community Center. Congressman Neil Abercrombie has been chosen to serve as Ranking Member (senior Democrat) on the Military Research and Development Subcommittee of the House Armed Services Committee for the 107 Congress (2001-02). Democratic members of the Armed Services Committee selected Abercrombie for the post at a meeting this afternoon.

The subcommittee exercises authority over all military research and development on programs, including activities conducted at the Pacific Missile Range Facility at Barking Sands, Kaua'i. Abercrombie will also continue to serve as a member of the Military Installations and Facilities Subcommittee, which oversees the military construction budget.
