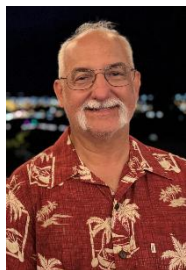

Department of War Transition from DS Logon to myAuth

The Department of War is transitioning from DS Logon to myAuth, a new digital credential system that simplifies access to various online services using a single account. myAuth improves upon DS Logon, the Department's legacy application, through secure multifactor authentication capabilities, a user-friendly interface, and improved customer support to ensure that users have secure, efficient access to their information. myAuth is currently available for logins to milConnect, ID Card Office Online, and Military OneSource and will be rolled out to additional websites throughout 2026.

To create a myAuth account:

1. Visit the ID Card Office Online website (<https://idco.dmdc.osd.mil/idco/>) select "Continue" under "Family ID Cards".
2. On the "New Login Requirement" page, select "Create Account" to initiate the process of creating a myAuth account.
3. Accept the "Standard Mandatory DOW Notice and Consent".
4. Follow the instructions provided:
 - a. Verify your identity with your CAC or DS Logon account.
(If you don't have a CAC or DS Logon Account, select "Create New DS Logon Account. Choose the "Email Registration" option and follow the on-screen prompts.)
 - b. Create your myAuth username by entering your email address.
 - c. Activate your account using the link in the "Welcome" email you will receive.
 - d. Set up your password and account methods as desired.
5. Once your account is successfully created, you will be redirected to the myAuth dashboard. Select the "IDCO Family ID Cards" tile to be automatically logged into IDCO to renew ID cards online.

News From Our Partners: USID Cards for Retirees, Spouses, & Dependents

Legacy paper-based USID cards with extended expiration dates issued to specific populations – e.g. Reserve Retirees and Former Members eligible for retired pay and benefits at age 60 – **as well as cards with indefinite expiration dates** issued to retirees, dependents over age 65, and Permanently Incapacitated dependents, **will remain valid until DOW determines when those legacy paper-based cards will be terminated – no termination date has been set.** Individuals with extended or indefinite (INDEF) expiration dates on their legacy paper-based USID card may replace those cards with a plastic-based USID card at their convenience.

Sponsors are encouraged to access their identification (ID) card records via the ID Card Office Online (<https://idco.dmdc.osd.mil/idco/>) "My Profile" option to ensure their record reflects both their current mailing and email addresses in advance. There are several ways to obtain a new USID card:

- Visit the ID Card Office Online website (<https://idco.dmdc.osd.mil/idco/>), select "Continue" under the "Family ID Cards" header and follow the prompts for Online USID Renewal. **Note: A myAuth account is required for logon**, or
- Visit the RAPIDS ID Card Office Locator website (<https://idco.dmdc.osd.mil/idco/locator>) to find the closest ID card office and schedule an appointment.

MOAA Again Recognized as a 'Top Lobbyist' by The Hill

MOAA's work on Capitol Hill on behalf of the uniformed services community has been recognized again by The Hill, one of the nation's top Beltway-focused news outlets, with a position on the publication's Top Lobbyists list for the 17th straight year.

MOAA was among the honorees in the 2023 Grassroots category, which included AARP, Burn Pits 360, and Veterans of Foreign Wars.

"This honor reflects not just the work of our Government Relations team on the Hill, but our entire headquarters team and our members and supporters throughout the country," said MOAA President and CEO Lt. Gen. Brian T. Kelly, USAF (Ret). "The grassroots support of our councils and chapters has been the backbone of our advocacy mission, along with the tens of thousands of MOAA members who bring our agenda items to their lawmakers via our Legislative Action Center. It's a yearlong group effort, and I'm proud to be a part of it."

MOAA's advocacy efforts in 2023 included:

- Bringing several key legislative proposals into the final stages of the FY 2024 National Defense Authorization Act (NDAA) negotiations, to include an increase in the Basic Allowance for Housing (BAH) and a requirement for a detailed report on beneficiary access to the TRICARE pharmacy network.
- Defending service-earned burial benefits by supporting H.R. 1413, the Expanding America's National Cemetery Act, which would authorize the transformation of a VA-run national cemetery into the next location affording military honors as Arlington National Cemetery reaches capacity. The final NDAA also may include language supporting this process.
- Hosting and contributing to a series of successful events in the nation's capital, spearheaded by our annual Advocacy in Action campaign, a congressional briefing on "TRICARE 101", and work alongside our partners in The Military Coalition on behalf of spouse employment programs and other common issues.
- Leading the ongoing push for passage of the Major Richard Star Act, which grew in co-sponsors throughout the year and now has the support of more than two-thirds of lawmakers.

MOAA's work on that issue, and many others, continues into the new year.

"Awards like this recognize the influence our organization and its members have on the Hill – providing even more motivation to continue our work on behalf of servicemembers past and present, their families, and their survivors," Kelly said. "The 118th Congress isn't over, and we need to take advantage of the progress we've made this year. With continued support from our membership, we'll push many of these long-term goals forward and will continue working with lawmakers from both parties to preserve service-earned benefits and strengthen the all-volunteer force."

What's In the FY 2026 NDAA ... and What's Next

MOAA-backed protections for health care access, improvements to medical staffing procedures, and expanded support for currently serving members and their families are part of the more than 3,000 pages that make up the must-pass defense policy bill as it begins the final stages to becoming law.

MOAA is reviewing the full text of the FY 2026 National Defense Authorization Act (NDAA) to determine how its provisions may affect servicemembers, families, retirees, veterans, and the broader uniformed services community. Below, you'll find a recap of some of the key provisions of interest to MOAA.

The negotiated language, attached to an existing Senate bill (S. 1071) is scheduled for a Dec. 10 vote in the House. The bill would then return to the Senate, which can advance the measure by passing the identical text without further amendment. Once both chambers approve the same language, the bill will proceed to the president for signature.

Key Provisions: Currently Serving

Pay Matters: A 3.8% increase to base pay across the board, a mandate to provide transparency on the calculation of the Basic Allowance for Housing (BAH), and an increase in Family Separation Allowance to \$300 a month, up from \$250.

PCS Report: The conference bill adopts the provisions of the House NDAA requiring the Pentagon to determine the extent of unreimbursed expenses servicemembers incur when they move to a new duty location. These include terminating utilities at old duty stations, security deposits at new duty stations, credit card charges associated with moves, costs associated with finding new employment for spouses, and pet relocation, among many others. Congress is looking to determine the impact on retention when there are so many ancillary tasks associated with frequent PCS moves.

Agent Orange Linked to Rare Blood Cancer That Develops Over Decades

WASHINGTON — Vietnam War veterans exposed to Agent Orange have a higher risk of developing a rare blood cancer that develops slowly over decades, according to a new study that for the first time links myelodysplastic syndrome to widespread use of the herbicide.

Researchers say the breakthrough could help veterans with the syndrome access benefits and services from the Department of Veterans Affairs.

Without medical evidence that affirms a connection between Agent Orange and MDS, patients with the syndrome have struggled to qualify for service-connected benefits, said Dr. Michael Sekeres, chief of hematology at Sylvester Comprehensive Cancer Center at the University of Miami. Researchers at Sylvester conducted the eight-year study.

About 20,000 new cases of MDS are identified in the U.S. each year. Patients typically are over age 70 at diagnosis.

"I see veterans who develop these conditions and need expensive medical care, but I can't write a letter that establishes causality because, before this study, we hadn't clearly linked Agent Orange to MDS," Sekeres said.

An estimated 2.6 million service members likely were exposed to Agent Orange, according to researchers who disclosed their findings at the annual convention of the American Society of Hematology, which is being held this week in Florida.

Myelodysplastic syndrome, known as MDS, is a group of rare blood cancers that develop when a person's DNA is damaged. The disease progresses from a series of genetic mutations in blood stem cells, according to researchers.

Individuals exposed to Agent Orange tend to develop MDS earlier, according to the study's findings. They also are more likely to have aggressive forms of MDS that advance to acute myeloid leukemia, which is cancer of the blood and bone marrow.

"Many veterans and doctors have long questioned whether Agent Orange exposure during the Vietnam War contributed to cases of MDS. The chemical is linked to several cancers, but a link to MDS was unclear. This created real barriers for exposed veterans with MDS who are seeking care and disability benefits," the Sylvester Comprehensive Cancer Center said this week.

The U.S. military sprayed Agent Orange to clear jungles and destroy enemy food crops. The defoliant was widely used at military installations, along roads and to clear paths to install communication lines.

Between 1962 and 1971, the U.S. military spread more than 19 million gallons of herbicide over forests in Vietnam, Cambodia and Laos.

"Though Agent Orange was not the only herbicide used, it was the most prevalent. Exposure to the chemicals from these operations has resulted in serious and ongoing health issues for Vietnam War veterans," according to Disabled American Veterans, a national advocacy group.

Agent Orange was banned in 1971, and inventories were destroyed as scientists learned about the dangerous health effects of exposure. Troops who served in Vietnam or in waterways throughout the country between 1962 and 1975 are eligible for certain VA benefits for illnesses connected to Agent Orange exposure.

Exposure to the herbicide has been linked to non-Hodgkin lymphoma, multiple myeloma, leukemia, prostate cancer, Parkinson's disease, ischemic heart disease, diabetes and birth defects that include spina bifida.
